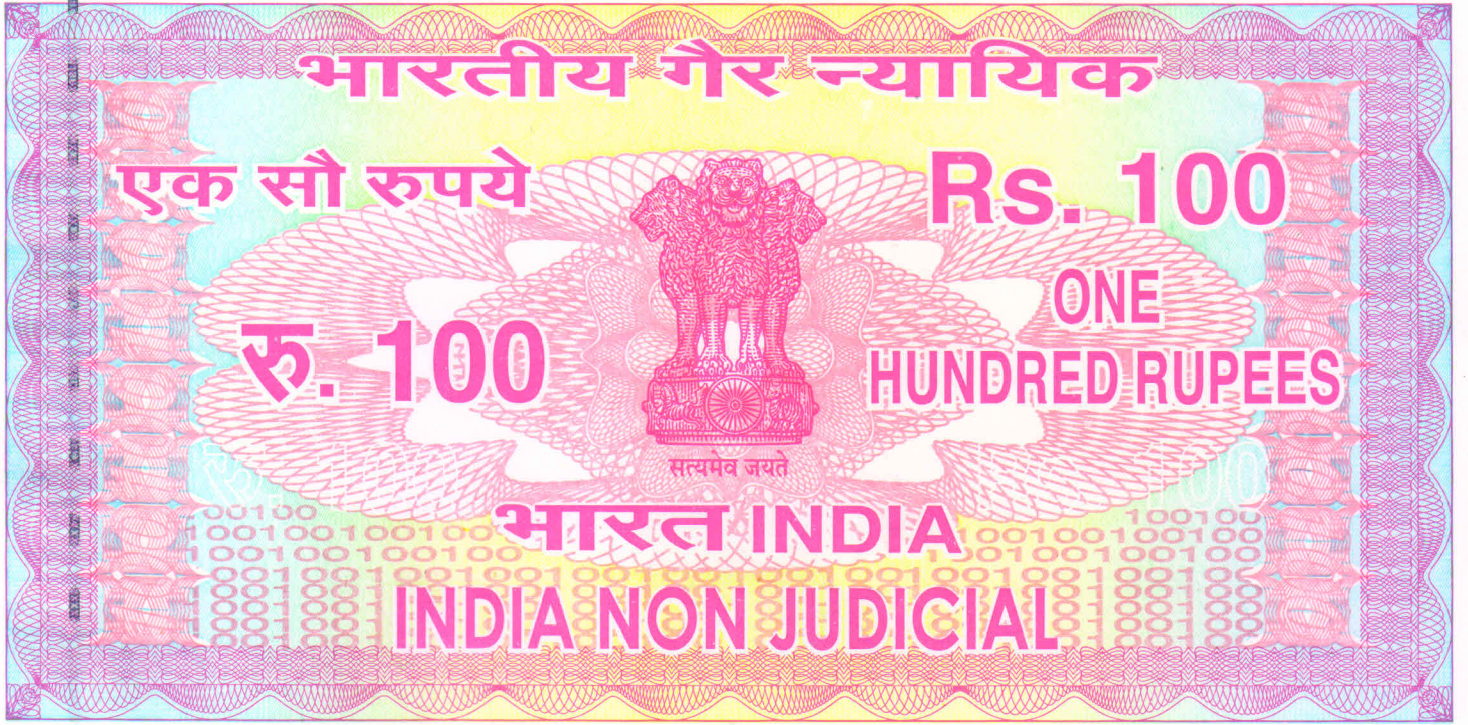

I. OBJECTIVES

Under this MOU these institutions intend to promote cooperation which will advance educational and research activities as well as opportunities for faculty, staff and students to contribute to innovation in education leading to restructuring of courses, new methods of teaching and learning and integral development of personality, through School of Arabic and Islamic Studies and IISR.

II. ACTIONS

Actions that may be carried out under this MOU include:


1. Discussion to explore the development of cooperation in the field of teaching and research;
2. Discussions pertaining to potential joint research activities;
3. Discussions regarding faculty exchange for purposes of study, research, lectures, talks, symposiums, conversations and sharing experiences.
4. The parties agree that research results obtained through joint activities shall be jointly owned by the parties in accordance with the provisions mutually decided upon.
5. Further are as for cooperation may be agreed from time to time.

III. DURATION, MODIFICATIONS AND TERMINATION


This MoU comes into force on the day when representatives of these two institutions affix their signatures, and is valid for five years and may be modified or extended by written amendment executed by both institutions. This MOU may be terminated for any reason by either institution by giving six months written notice prior to such termination.

IV. Dispute Resolution

1. This MOU is entered into by the institutions in good faith. These institutions will use their best efforts to resolve any conflict or dispute which may arise

regarding the interpretation and enforcement of this MOU. Any disputes or conflicts which cannot be resolved at the appropriate operating level shall be referred to the authorized representatives of IISR and BSACIST and they shall meet not later than fifteen (15) working days after receipt of notice by either party of request for dispute resolution or shall enter into negotiation with good faith in resolving dispute.

2. If the representatives are unable to reach a mutually satisfactory resolution of the dispute within the next fifteen (15) working days, each party shall within seven working days, designate top management executives who shall attempt to resolve the dispute over the next fifteen (15) days.
3. In the event of dispute not resolved as mentioned at clauses IV.1 and IV.2, the same shall be resolved through arbitration and the arbitrator shall be appointed mutually by both the parties to this MOU.

V. Financials

There are no financial commitments whatsoever by any institute, unless agreed upon through a separate agreement or contract for any joint project or joint research activity.
