1.	Level I	Request by the student in the answer script to show mercy by way of awarding more than the deserving marks	
2.		The student is causing suspicious movement with the intention of getting help from others or providing help to others	Warn the student for the first time. However, he/she has to be booked with the form for the COE Office record.
3.		The student communicates with neighboring student(s) orally or non-verbally, with the intention of getting help from others or providing help to others	

Sl. No.	Level	Nature of Malpractice	Punishment
1.	Level II	The student repeating any one or more of the malpractices listed in Level I for the second time.	The answer script of that Test / Examination shall be invalidated, by awarding zero marks. The student shall not be eligible for a substitute for that Test.
2.		The student copying from a neighboring student or copying from any incriminating material(s).

Sl. No.	Level	Nature of Malpractice	Punishment
3.	Level II	The student possessing any Incriminating material(s). For example: written or printed materials, bits of papers containing writings information, writings on scale, calculator, hand kerchief, dress, part of the body, table, walls, Hall Tickets etc.	The answer script of that Test / Examination shall be invalidated, by awarding zero marks. The student shall not be eligible for a substitute for that Test.
4.		The student possessing cell phone / programmable calculator / any other electronic gadgets.	
5.		The student possessing his/her question paper with additional writing on it.	
6.		Appeal by the student in the answer script, coupled with a promise of any form of consideration.	
7.		The student possessing the question paper of another student with additional writing on it.	
8.		The student passing his/her question paper with additional writing on it to another student.

Sl. No.	Level	Nature of Malpractice	Punishment
1.	Level III	The student repeating any one or more of the malpractices listed in Level II for the second time.	1. CAT Exam: All Theory courses of that particular CAT shall be invalidated by awarding zero marks. The student shall not be eligible for a substitute for that CAT.
2.		The student possessing, answer script of another student.	
4.		The student passes his/her answer script to another student.	
5.		Vulgar/offensive writings by the student in the answer script	2. Semester End Examination: All Theory & Practical Courses registered in the respective Exam session shall be invalidated by awarding zero marks.
6.		Misbehavior in the Test / Examination Hall (unruly conduct in the Hall, threatening the Test / Examination officials).	

Sl. No.	Level	Nature of Malpractice	Punishment
1.	Level IV	The student repeating any one or more of the malpractices listed in Level III.	The Test / Examination of all the theory and practical courses registered for the examination session by the student shall be invalidated by awarding zero marks, and the student shall be expelled from the Degree programme by issuing T.C.
2.		A student involved in a paper chase or any other unethical approach in the evaluation process.	

Note:

If a student fails to report before the Enquiry Committee on the date and time specified in the malpractice booking form, it will be considered as Malpractice of Level II and a fine amount of Rs. 2,000/- shall be imposed on the student.
